I would be grateful if you would ensure that the Inspector has the information below before the Inquiry closes today.

Dear Sir,

Yesterday you kindly gave me leave to come back to you with information as to how the £1,133 per dwelling amount used to calculate the Public Transport Service Contribution, was determined. I am not able to provide any documentation but Dave Harrison, OCC's Public Transport Team Leader, has been able to provide more detail as to how the amount was determined.

An amount per dwelling was determined in 2018 and at that time the amount per dwelling was £1,000. This amount was based on an estimate, at that time, of the cost of procuring a commercially viable new service on a pump priming basis; two additional vehicles, pump primed over 5 years being £800.000 as set out below –

The total cost of procuring the service was then divided by the number of new dwellings assumed to be built on the route, the route being Burford-Witney-Woodstock corridor and the expected sites were

The £800,000 was divided by the total number of new dwellings (800) to give the amount per dwelling of £1,000.

Since 2018 the amount has been uplifted annually to give a cost per dwelling of £1,133 as at December 2021.
